

Immigration applications:

In our immigration department we act for both individuals and businesses. In both cases we offer an initial fixed fee appointment to take instructions and information on the particular circumstances of the individual or business. We can then tailor the advice and costs based on those particular circumstances and the application that will be made. The costs of the fixed fee appointment can range between £99 to £190 plus VAT ((£118.80 / £228) depending on the complexity of the advice needed and immigration history.

In fact any fees quoted below are dependant on an on an applicant's immigration background and complexity of the case. All fees quoted exclude disbursements: Disbursements are payments to third party agencies and include the Home Office application fees/ Court fees/ translation costs.

The Home Office fees vary for each application type, a link to the Home Office fees can be found here but change annually:

Should an interpreter be required or documents need to be translated, these are charged independently and hourly and range from £50 to £100 per hour.

£1100-£1500 plus VAT (£1320 / £1800)
- Entry Clearance – Family Reunion
£1100-£1500 plus VAT (£1320 / £1800 per main applicant with and additional cost of £200 plus VAT (£240) per dependant
- Indefinite Leave to Remain/ Settlement in all categories
£1200 - £1900 plus VAT (£1440 / £2280)
- Private Life (Article 8)
£1200 - £1900 plus VAT (£1440 / £2280)

- UK Ancestry
£1100-£1500 plus VAT (£1320 / £1800)
- Naturalisation/ Registration as British Citizen
£800 fixed fee plus VAT (£960)
- Tier 4 Student Visa
£1000 - £1300 plus Vat (£1200 / £1560)
- EU Application
£800 - £1000 plus VAT (£960 / £1200)
- In Country Appeal (Preparation of appeal to the First Tier Tribunal)
£2500 plus Vat (£3000) (plus disbursements, these include Court Fees of £140, Counsel's fee estimated at £800-£2500 plus VAT (£960 / £3000) per Court appearance)
- Deportation
£3000 - £5000 plus VAT (£3600 / £6000) (plus disbursements)
- Adult Dependent
£2000 - £2500 plus VAT (£2400 / £3000)
- Judicial Review
£4000 - £6000 plus VAT (£4800 / £7200) (plus disbursements)
- Tier 1 Investor Visa
£10,000 - £12,000 plus VAT (£12000 / £14400)
- Tier 1 Entrepreneur Visa
£7000 - £9000 plus Vat (£8400 / £10800)
- Tier 2 (General, Intra- Company Transfer, Sportspeople, Minister of Religious Workers)
£2800 - £3500 plus VAT (£3360 / £4200) (plus £300 plus Vat (£360) per dependent)
- Tier 2 and Tier 4 Sponsor Licence
£5000 - £10,000 plus VAT (£6000 / £12000) (depending on the size of the employer)
